COMMITTEE MEMBERS PRESENT: *Chairman Rudy Smith, Vice-Chairman Alex Flint, Weldon Wall, Freddie L. Brantley, and Leo Gaston Jr. were in attendance.*

I. CALL TO ORDER: *Meeting called to order at 3:00 p.m. by Chairman Rudy Smith.*

II. INVOCATION: *Led by Mr. Alex Flint*

III. PLEDGE OF ALLEGIANCE: *Led by Chairman Smith.*

IV. APPROVAL OF THE MINUTES: *Mr. Alex Flint made the motion for the approval of the minutes, and Mr. Freddie Brantley second it.*

V. PUBLIC COMMENTS: *There were no Public Comments.*

VI. OLD BUSINESS: MR. ANDY FULGHUM: DRAINAGE STUDY PROPOSAL (MR. NATHANIEL WRIGHT'S PROPERTY). *Mr. Fulghum presented the proposed study for Mr. Wright's property, and asked if the Transportation Committee wanted to move forward with it. Mr. Chairman asked for a motion to move forward, but spend no more than \$20,000 on the study. Mr. Alex Flint made the motion, and was second by Mr. Leo Gaston. The Committee voted unanimously YES, and the motion was approved. Mr. Fulghum also presented an overview on the SALES Tax Program Update, and expressed that this is a continuing project. VII. NEW BUSINESS: MR. MALZONE RUSSELL: REQUEST FUNDS FOR— CONSIDERATION OF FUNDING FOR RESURFACING OF SECONDARY 341 (FORDVILLE ROAD). *Mr. Russell presented a request to the Committee to consider*

Funding for Secondary 341- Fordville Road in the amount of \$914,452.50. Vice-Chairman Alex Flint made a motion to approve the funding in the amount of \$914,452.50. for resurfacing Secondary 341 (Fordville Road), and Mr. Leo Gaston second it. The Committee voted unanimously YES, and the motion was passed and approved. Mr. Russell also presented proposed NEW PROJECT update.

- 1. The funded CTC resurfacing of S-243 Floyd Road is in the SCDOT system to be established. No current letting date scheduled.*
- 2. The Funded CTC resurfacing of SC-3, S-43 and S-278 is scheduled to be Let in July 2020.*
- 3. The widening of US-17 from Ga to SC-315 is scheduled to be Let in August 2020.*
